



We have a lot on our platter for the 2025 season. Here's just a sample of our offerings:

As always, the Friends have a large series of work sessions planned in both the Chama and Antonito yards, as well as in Cumbres, Sublette, Osier, and the Colorado Springs CRF. You can follow our volunteer projects through the Friends website, the Dispatch Extra and the schedules published in the quarterly C&TS Dispatch and social media.

This year the Friends will have three charter trains based out of Chama. We hope you didn't miss the Members' BBQ dinner and train ride that took place on June 20<sup>th</sup>.

Our Moonlight and Wine Train, featuring New Mexico wines, steams on August 2nd and a two-day Photo Charter is scheduled October 26<sup>th</sup> and 27<sup>th</sup>. There will also be a special K-36 100<sup>th</sup> Anniversary event, Wednesday through Friday, August 13<sup>th</sup> through 15<sup>th</sup>, including a Behind-the-Scenes History Tour of the normally off-limits historic coaling tipple and work-shop facilities.

The Friends have several new publications available for 2025, including a eight-page Complementary Issue of our Dispatch magazine and a pocket-sized Brochure. # Opening Day, 2025

The 2025 season opened on May 31...almost. At Chama, there was a decent turnout of passengers and celebrants. K-36 No. 484 did the honors pulling the first train out to Osier and back. The Osier turns ran daily that first week except one day when the train was canceled due to a mechanical problem.



As always, the Opening Day events in Antonito began with a blessing from the local clergy. However, a plan to use the Railroad's new Diesel 114 for the opening train had to be abandoned when a test run the day before was unsuccessful. The locomotive suffered an equipment failure on the way back from Osier.



Fortunately, crews worked on 168 on Saturday and it was available for the Sunday departure. Due to its size and tractive effort, it was limited to pulling the three premium cars as far as Osier and back. 168 has worked most days but the train was canceled a couple of times due to mechanical issues.

## Current Locomotive Status, June 19, 2025

- 484 was out of service for one day due to a "not serious" mechanical problem. It's now back in regular duty.
- 487 is being reassembled after new cylinder liners were fitted. Almost ready for test runs. Hopefully ready for work soon.
- 488 is being worked on in Chama with issues with spring rigging. It is still several days away from being ready.
- 489's drivers have been sent away for turning.
- 463's drivers have been dropped, the old tires removed, and the wheels sent away for turning. New tires waiting in Chama for their return.
- 168 didn't run for one day, issues with valve timing, now repaired
- 315 still needs boiler work
- 114 (Diesel) has electronic issues, currently undergoing diagnosis.

## Wanted: Chair of the Friends Safety Committee



The Friends are looking for a **Safety Officer** to administer the Friends Safety Program. As Safety Officer and Chair of the Safety Committee, he or she will work with the C&TS Railroad Safety Officer to ensure a safe environment for Friends volunteers and direct safety programs at work sessions. He or she must have experience in the safety field or has been involved in safety in the private sector such, as an *Operation Lifesaver* volunteer providing safety training for the general public. The person must also have good communication skills in order to explain safety issues to volunteers, especially when working around railroad operations.

The **Friends Safety Committee** serves as a focal point for the development of plans, policies and procedures designed to enhance the effectiveness of safety as it relates to the Friends' mission. The Committee's goal is to promote the Friends Safety Program by techniques, developments, effective safety practices and standards. There are five members on the Committee with a Safety Officer and alternate. The Friends Safety Committee convenes once a year at the fall meeting and deals with issues relating to safety throughout the year. We try to broadcast the meeting over the web (via *Teams* or *Zoom*) for those who cannot attend in person.

# A Paper Trail of C&TS Railroading: 1969-2025

Wouldn't we all like to wander back to the "seasons our youth," at least as far as narrow gauge railroading is concerned? Smoke and steam! Long strings of loaded box cars, cattle cars and tank cars crawling up the pass toward Cumbres!! Getting a ride in the caboose. Or maybe just standing trackside and watching and listening as a train rumbles past.

Thanks to the Cumbres & Toltec Scenic Railroad, that's exactly what we do. We even think back to when our parents or grandparents did the same in their day.


Most of us weren't around for early days of the C&TS. But thanks to back issues of the *C&TS Dispatch* online and the vast collection of printed materials about both the

Railroad and the Friends that can be found in the Friends Library in Albuquerque, one can go "back through the years" and enjoy the C&TS in those early days between Chama and Antonito.

What follows is but a small part of the Friends Library's collection, a sample of the many events, projects, successes—and a few problems—that represent the Friend's history since the two states purchased the 64-mile line back in 1970, and Bill Lock organized the Friends as a formal, incorporated group of volunteers in 1988.

As members of the Friends of the C&TS, we can all be proud of the time, efforts and dollars we have contributed to the Railroad's survival, restoration and history in New Mexico and Colorado.


Whether you are a new member of the Friends or a seasoned volunteer, here is a paper trail you can follow that reflects the last fifty-five years of historic narrow gauge railroading on the C&TS. Enjoy! **Chris James ~ Editor**



**[FAR LEFT]** By 1969, the D&RG was ready to scrap the entire line east of Durango. The public, politicians and railfans had other ideas. In 1970, the Cumbres & Toltec Scenic Railroad was created with ancient locomotives, deteriorating rolling stock and tumble-down buildings, but an enthusiastic following. The Railroad "will run again (with people.)"

**[BELOW]** Even in the earliest years of the Cumbres & Toltec, the tickets and timetables looked as professional as any mainline railroad in the early 20<sup>th</sup> century. Why, one might even expect to see an upper-crust gentleman like Lucius Beebe riding the line through the aspen trees in support of the Santa Fe Opera!

**[BELOW]** In 1972, the C&TS had only two locomotives in operation, K36s 483 and 484. Special events often used the 1943 "Pineapple," an ex-Navy diesel acquired from Hawai'i. It is still used today as a yard switcher.



**The Friends** wouldn't exist for another ten years so the Railroad Club of New Mexico and the Narrow Gauge Railroad Association handled the membership.



In 1973 the call went out for “Car Attendants,” the precursor of today’s Docents, who handed out literature, watched for safety issues among the passengers, answered questions and reported problems and complaints. Volunteers began offering two “Back to Back Work Sessions” Wednesdays through Fridays in July and August. Later that summer, K-36 487 entered the locomotive roster. This gave the C&TS three operational locomotives. The ICC granted 484 a one year extension on its required inspection. 487 would take up 484’s duties in 1974.

1974 started out well with the first Rotary Plow event on the C&TS. But in June it was announced that Scenic Railways, the Railroads operator, would start using Diesel #19, the “Pineapple” for regular trips. Approval of the Diesel in 1972 was “temporary,” though Scenic Railways thought otherwise. The State Railroad Authority was not happy, as the line was supposed to be steam only. Only twenty steam runs were made during 1974..

The 1973-4 oil embargo occurred at exactly the wrong time for the C&TS. With limited gasoline, tourist traffic dwindled, a difficult situation for the new Railroad”

[ABOVE] Not good news: “Business conditions have forced a substantial reduction in days of operation. To avoid disappointment obtain firm reservations before traveling to the C&TS RR this year.”


By late season 1974, “a day of excitement” was once again possible as tourists were returning and steam locomotive operation was slowly getting back to normal.

In 1974, the Chama Centennial Commission proposed building a new Chama depot. We can all be thankful that the original depot is still standing as a testament to the history of the Denver & Rio Grande and the Cumbres & Toltec.



By 1975, animosity was growing between the NGRRA and Scenic Railways, including Car Attendants’ negative opinions about Scenic, the employees, and the Railroad. These continued conflicts spilled over into the 1976 operating season. Over the next few years it would only get worse.




By 1976 and 1977, Scenic Railways decided it had enough of the NGRRA. The Railroad first banned the opinionated Car Attendants and later banned the NGRRA from working anywhere on the Railroad property. Volunteer help was over, at least for now, and willing volunteers would just have to wait.



## 1988: Welcome to the Friends of the Cumbres & Toltec Scenic Railroad, Inc.


**The transformation** toward today's Friends of the Cumbres & Toltec began in 1981. The Railroad, no longer operated by Scenic Railways, grudgingly allowed Bill Lock and a few volunteers back onto the property to restore some rolling stock. Over time, more and more volunteers began to arrive. The Railroad took notice and became more accepting to what Bill called the "Friends of the Cumbres & Toltec Scenic Railroad," an informal band of railfans with hammers and paint brushes.

In 1988, the Friends was incorporated as an official 501(c)3 non-profit organization and has never looked back. As time went on, more members joined up and photographic specials and charter trains began operating over the line and the quarterly C&TS Dispatch was created... on a typewriter.



**[ABOVE]** Unlike back in the early days of railroading, there have been no “catastrophic” events on the C&T; no head-on collisions, no major runaways, no spectacular derailments. That is until the night of June 23, 2010, when the Lobato Trestle caught fire. It burned through the night and, while only the wooden portion of the trestle burned, the intensity of the fire warped and weakened the girders and deck plates of the trestle. Repair was a herculean effort that cost over \$1 million dollars. Reconstruction took a year but the 1883 bridge was not only restored but strengthened, thanks to bi-state funding and generous donations from the Friends. **D&RG EXPRESS CAR 163 RESTORATION AT THE COLORADO SPRINGS CRF**

*Spring work on Express 163 continued with the initial demolition of the roof and the metal-clad cover of the clerestory.*



*The east end roof arch was installed in June. Much of the work will stop during the summer work sessions up at the railroad.*

*Work continued inside with the fabrication and installation of rafters and car-lines (transverse bars wooden or metal bars that extends across the top of the car to support the roof and clerestory.)*

*Secrets of the Narrow-Gauge Railroad Queen: A Denver & Rio Grande Western RR Adventure*






